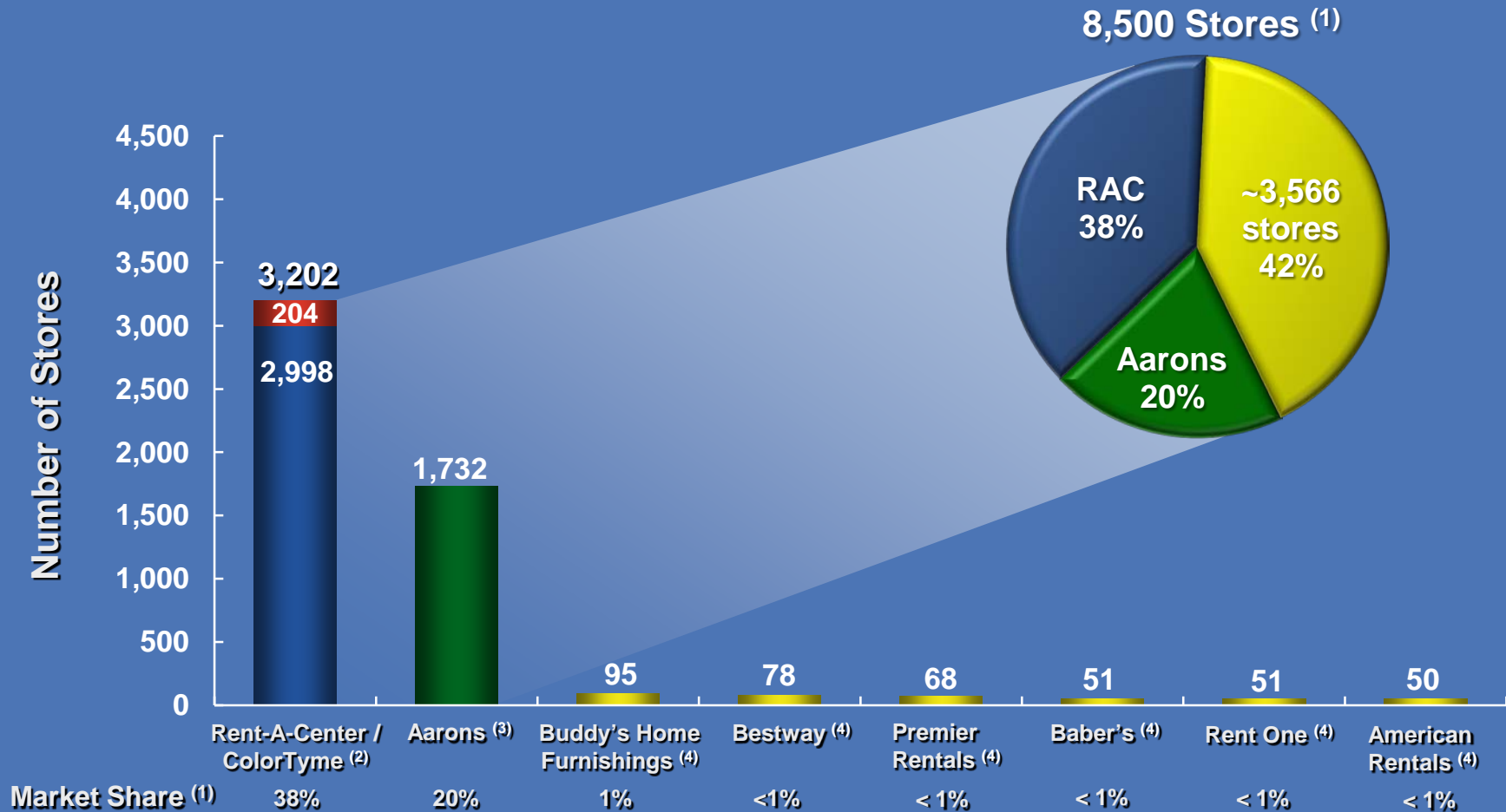


Leading RTO Operator in U.S.

 - 38% market share based on store count
 - National footprint of approximately 3,000 company-owned stores and 200 franchised stores
- Broad selection of high quality, brand-name merchandise under flexible rental purchase agreements
- Primarily serves the “underbanked” consumer
- Generated \$2.7 billion in LTM revenue and \$377.3 million in LTM adjusted EBITDA as of June 30, 2010

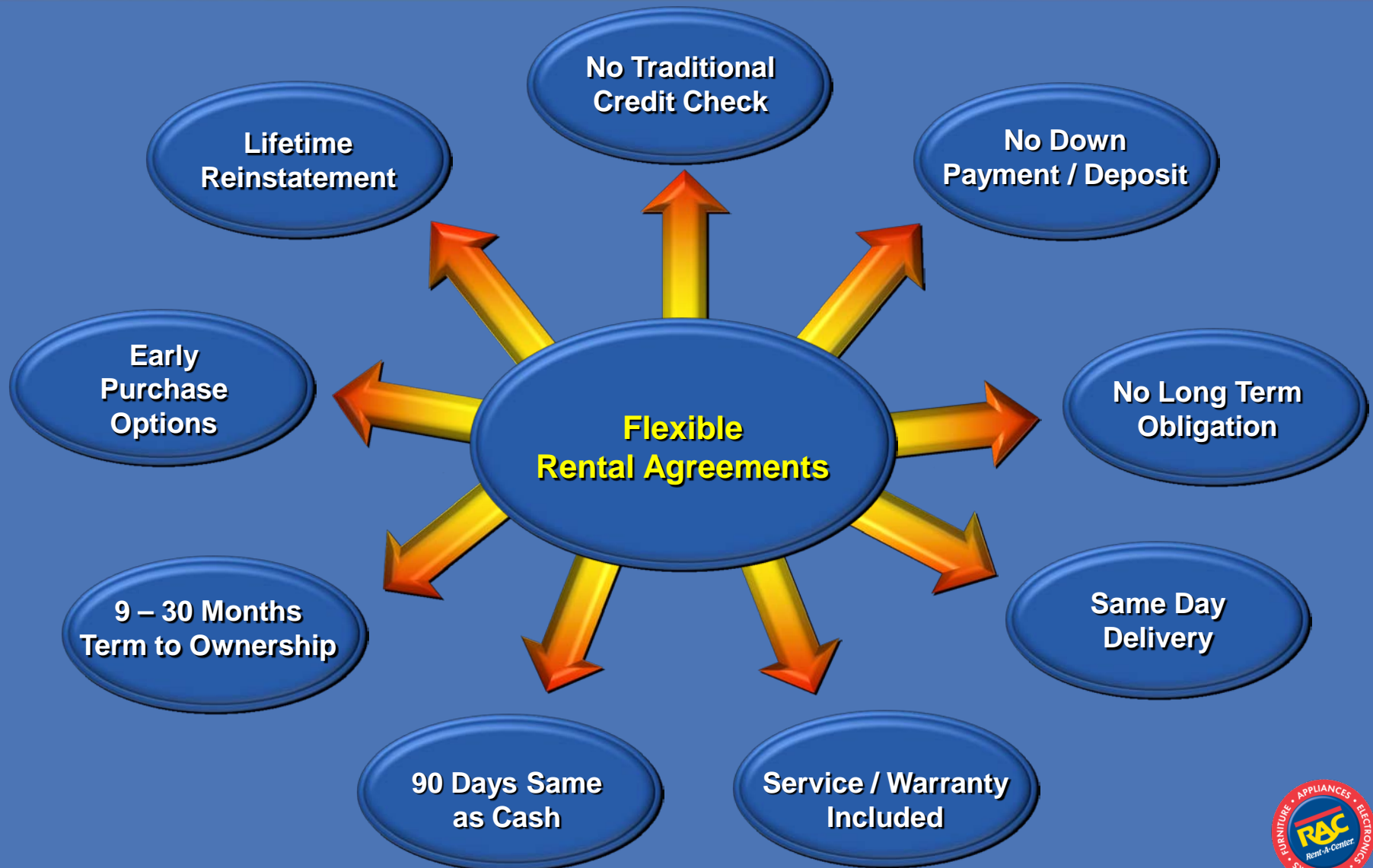

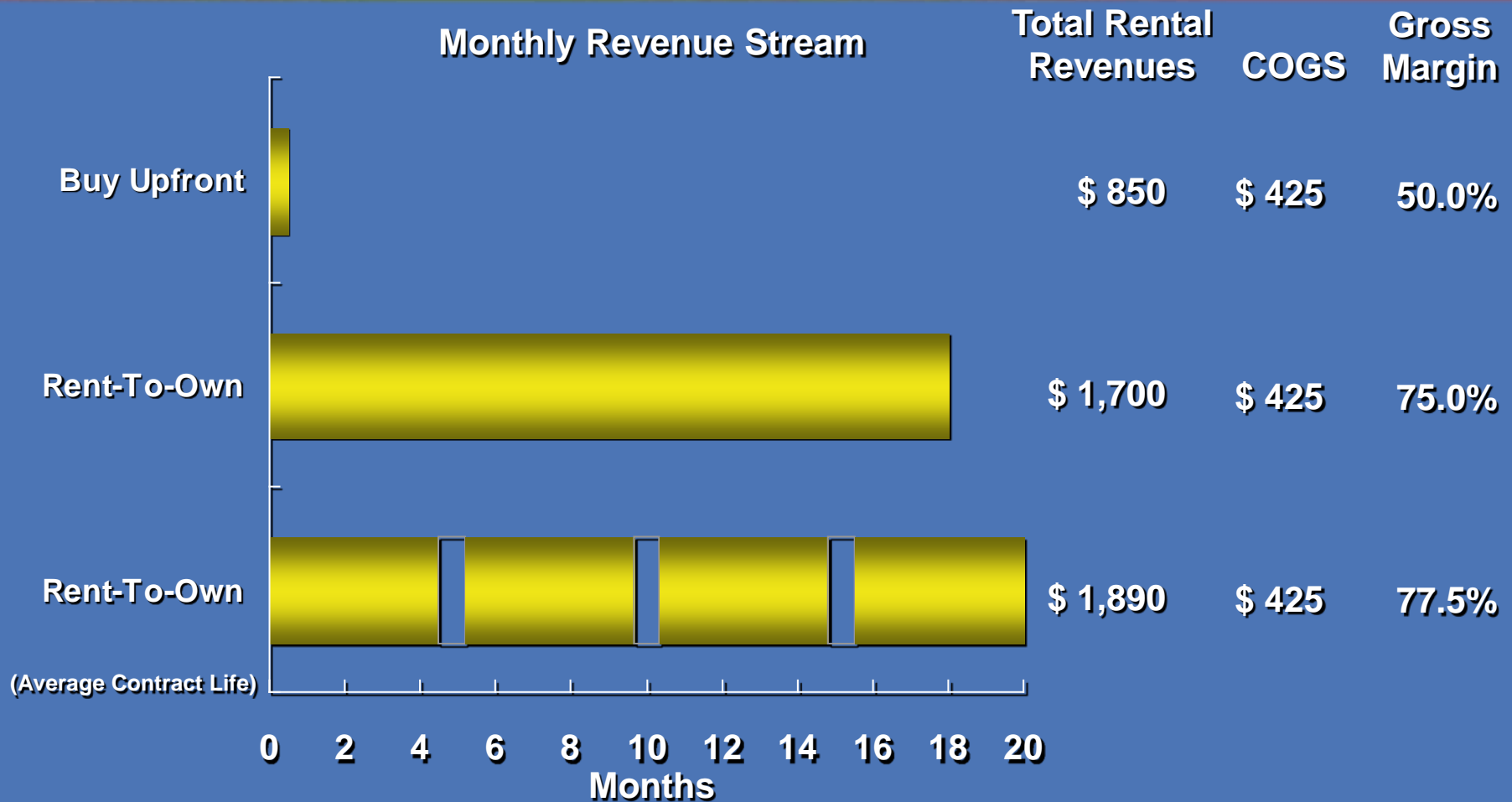
- Approximately 74% of customers in the rent-to-own industry have household incomes between \$15,000 and \$50,000 ⁽¹⁾

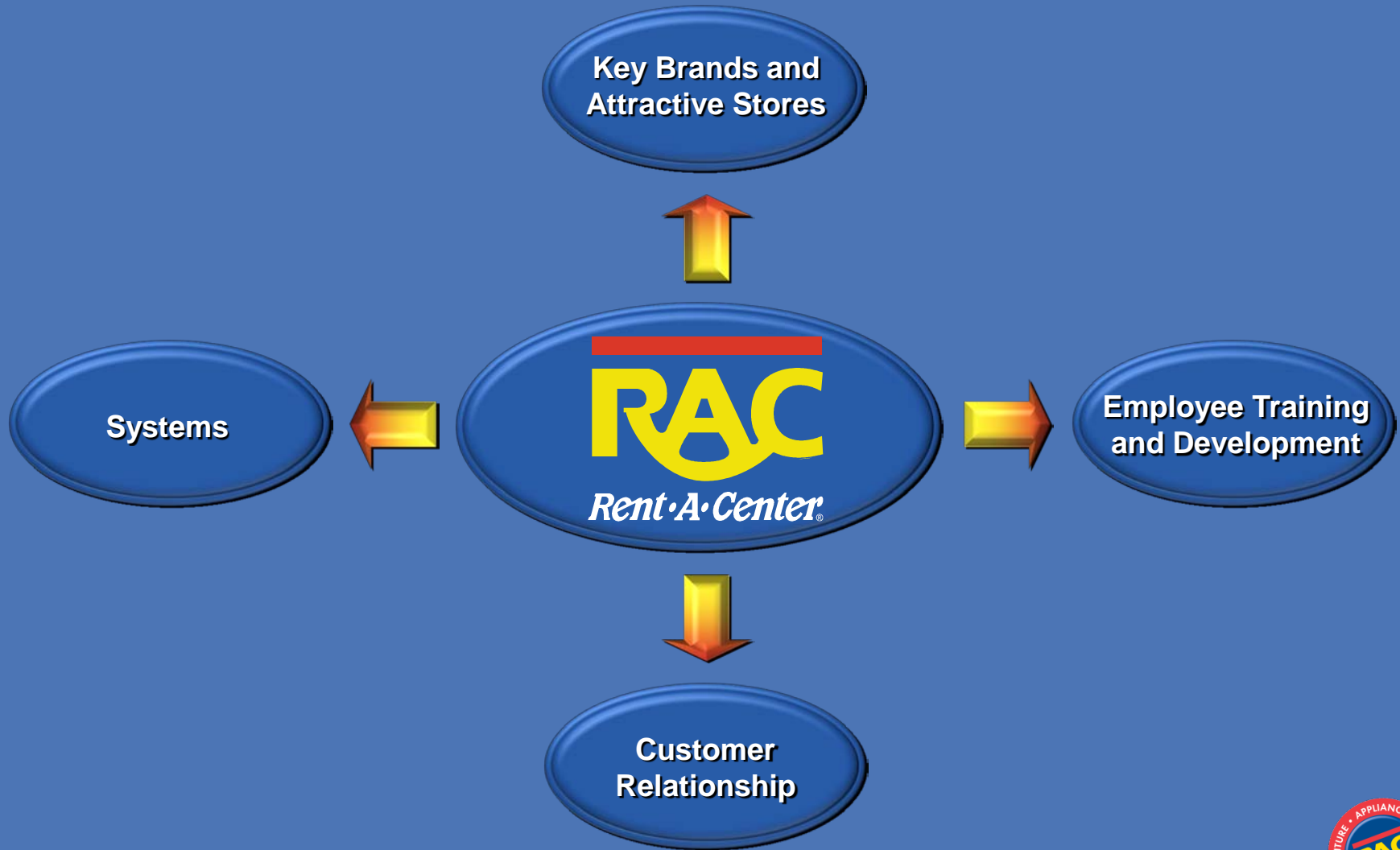
...With Attractive Economics

For 75% of our initial rental purchase agreements, the customer returns the merchandise before acquiring ownership and the average term of the agreement is 4 to 5 months.

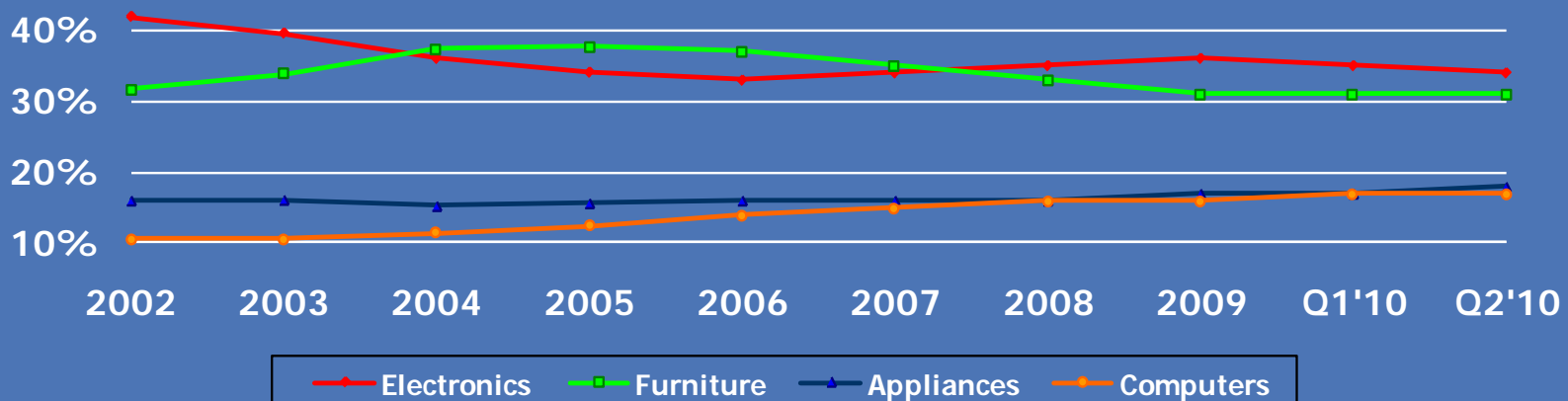
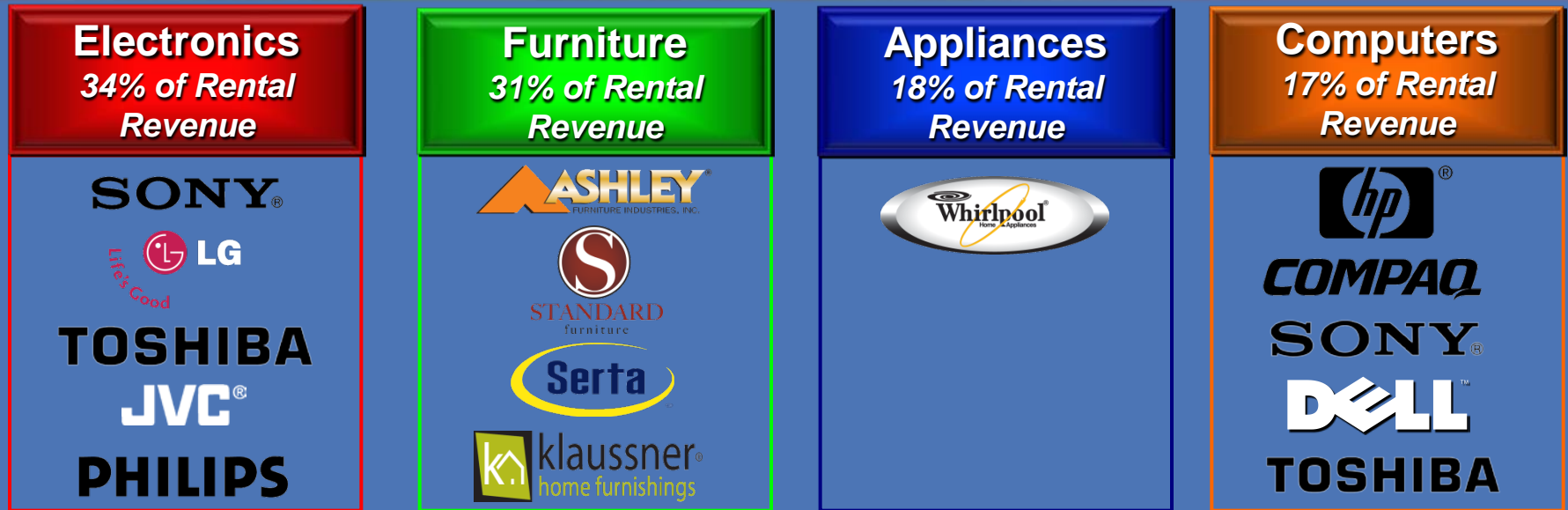

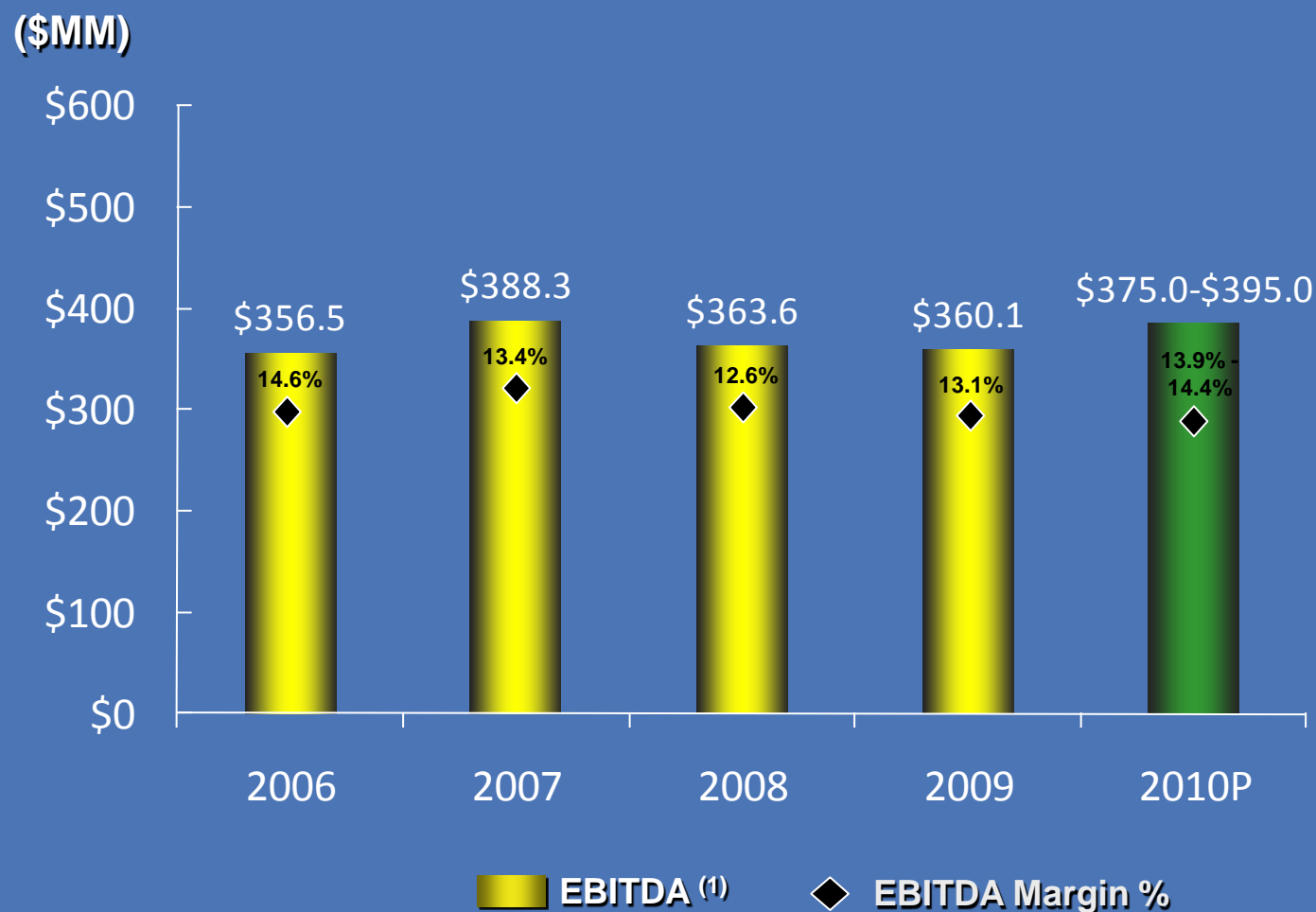
Financial Overview
